Terms and Conditions – Astoria Current, Astoria Palawan, Astoria Plaza, and Astoria Greenbelt

1. These terms and conditions apply to all offers unless specified otherwise.
2. Booking period: November 15, 2021 to March 31, 2022
3. Stay period: November 15, 2021 to May 31, 2022
4. Promo is not valid during peak season: December 23, 2021 to January 2, 2022 and April 14-17, 2022
5. The participating rooms are as follows: Standard Room for Astoria Current, Superior Room for Astoria Palawan, One-Bedroom Suite for Astoria Plaza, and Standard Room for Astoria Greenbelt
6. Minimum length of stay:
 - For Astoria Current and Astoria Palawan, minimum of 2 nights' consecutive stay is required.
 - For Astoria Plaza and Astoria Greenbelt, minimum of 5 nights' consecutive stay is required for vaccinated guests coming from Green and Yellow Countries. On the other hand, minimum of 7 nights' consecutive stay is required for non-vaccinated guests and guests coming from non-Green and Yellow Countries. This is in compliance with the guidelines released by the Inter-Agency Task Force for the Management of Emerging Infectious Diseases (IATF-EID). This is subject to change depending on the advisory of the IATF-EID.
7. Prior reservation is required, and rooms are subject to availability.
8. Pursuant to IATF-EID directives, we shall be limiting the number of guests per room. Also, all guests shall be asked to provide copies of their government IDs and file a health declaration form prior entry to hotel premises.
9. Booking specifics per property:
 - All RCBC cardholders may now avail of the promo and book at Astoria Current.
 - Only cardholders locally residing in Palawan can avail of the promo and book at Astoria Palawan for the time being. This is subject to change depending on the advisory of the IATF-EID. Once restrictions are lifted, all local cardholders, including those residing outside of Palawan, will be allowed to avail of the promo and book at Astoria Palawan.
 - Only quarantine bookings are allowed at Astoria Plaza and Astoria Greenbelt for the time being.
10. RT-PCR test requirements:
 - A negative nasopharyngeal swab RT-PCR test released not more than forty-eight (48) hours prior to arrival at the airport is required when staying at Astoria Palawan. On the other hand, a negative saliva-based or nasopharyngeal swab RT-PCR test released not more than seventy-two (72) hours prior to arrival at the airport is required when staying at Astoria Current.
 - For Astoria Plaza and Astoria Greenbelt, RT-PCR test arrangements must be made upon arrival at the airport. It is to be administered on the 5th or 7th day of stay at the hotel by accredited government agencies.
